**Update:**

On Thursday February 24, 2011, Officers from the San Jacinto Police Department responded to a report of a missing person in the 1600 block of San Jacinto Avenue, San Jacinto. Investigators from the San Jacinto Police Station were called to the scene and assumed the investigation. Photographs of the missing person, Lynnette Elda Donahoe, 60 years, of San Jacinto, were distributed in the San Jacinto Valley, as well as neighboring cities and counties.

Investigators have exhausted all potential leads and are asking for help from the public. Donahoe was reportedly last seen in the Lake Arrowhead area of San Bernardino County on February 18, 2011, knocking on doors near the scene of a traffic collision in which her vehicle was left abandoned.

Donahoe has a history of mental health issues and is described as being 5'-4", 140 lbs., with hazel eyes, short red hair, and wearing glasses.

**Details:**

On February 24, 2011, the San Jacinto Police Department responded to a report of a missing person call in the 1600 block of San Jacinto Avenue, San Jacinto. **Lynnette Elda Donahoe**, 60 years, of San Jacinto, was reported missing by a family member, who had last spoken with her on February, 18, 2011. Investigators recently learned Donahoe was involved in a traffic collision in the Lake Arrowhead area of San Bernardino County on February 18, 2011. Donahoe was last seen walking from the collision and knocking on doors of residences in the area. The San Bernardino Sheriff's Department has conducted an extensive search of the area for Donahoe without success.

Donahoe is described as a white female adult, 60 years of age, approximately 5'-4", 140 lbs., with hazel eyes, short red hair, and wearing glasses.
